WHEREAS: Waterloo Township has reviewed this application and attached documents, reports, and plans, and

WHEREAS: The zoning on the described property is Agriculture District (AG-2), and

WHEREAS: Aggregate Resources, Inc has applied for a Conditional Use Approval Permit for the land described in the application site plan, and

WHEREAS: Waterloo Township has reviewed the requirements for a Financial Guarantee as described in the Sand and Gravel Ordinance, Section 8. Financial Guarantee and Indemnity Insurance and determines that the necessary amount is \$ 430,000, and

WHEREAS: Waterloo Township has adopted a Fee Schedule for activities related to Sand and Gravel Extraction Applications and determines that the Total Fee for this application is \$ 15,375.36.

NOW THEREFORE BE IT RESOLVED: The Waterloo Township Board approves the following plans, as attached:

1. SITE PLAN
2. GRADING AND LANDSCAPING PLAN
3. RESTORATION SEQUENCE PLAN

NOW BE IT FURTHER RESOLVED: The Waterloo Township Board approves the Sand and Gravel Operation Permit required by Sand and Gravel Ordinance for one (1) year, subject to all provisions of that Ordinance and any subsequent amendments adopted, and

NOW BE IT FURTHER RESOLVED: That the Financial Guarantee is set at \$ 430,000, and

NOW BE IT FURTHER RESOLVED: That the Total Fee for the APPLICATION FOR OPERATING PERMIT FOR EXTRACTION OF SAND AND GRAVEL is: \$ 15,325,36 and

This Permit does not become effective unless required fees, financial guarantees and indemnity insurance are deposited/filed to the satisfaction of the Township, and Aggregate Resources, Inc. has been granted a Special Conditional Use Permit for Sand and Gravel Extraction Operation


