**ORDINANCE FOR ADOPTION OF THE 1993 BOCA NATIONAL MECHANICAL CODE & 1992 CABO DWELLING CODE**

Ordinance Number 93-07-20-3

**AN ORDINANCE ESTABLISHING THE MINIMUM REGULATIONS GOVERNING THE DESIGN, INSTALLATION AND CONSTRUCTION OF MECHANICAL SYSTEMS, BY PROVIDING REASONABLE SAFEGUARDS TO PROTECT THE PUBLIC HEALTH AND SAFETY AGAINST THE HAZARDS OF INADEQUATE, DEFECTIVE OR UNSAFE MECHANICAL SYSTEMS AND INSTALLATIONS; KNOWN AS THE MECHANICAL CODE;**

Be it ordained by the Township of Waterloo as follows:

**SECTION I. ADOPTION OF MECHANICAL CODE**

That a certain document, three (3) copies of which are on file in the office of the Township Clerk of the Township of Waterloo, being marked and designated as "The BOCA National Mechanical Code, 1993" and the "Council of American Building Officials, first addition, 1992 Edition, be and is hereby adopted as the Mechanical Code of the Township of Waterloo in the State of Michigan; for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions and terms of said BOCA National Mechanical Code & the CABO Dwelling Code are hereby referred to, adopted and made a part hereof, as if fully set out in this ordinance, with the additions, insertions and changes, if any, prescribed in Section 3 of this Ordinance.

**SECTION 2. Inconsistent Ordinances Repealed.**

All other ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 3. ADDITIONS, INSERTIONS AND CHANGES, BOCA ONLY**

That the following sections are hereby revised as follows:

Section M-100.1 (page 1, second line). Insert Waterloo Township

Section M-114.2 (page 7, third line). Insert: as set by Waterloo Township Board

Section M-114.3 Insert: As set by the Waterloo Township Board.

SECTION 4. SAVING CLAUSE.

That nothing in this Ordinance or in the Plumbing Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or Ordinance hereby repealed as cited in Section 2 of this Ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

SECTION 5. DATE OF EFFECT.

That the Township Clerk shall certify to the adoption of this Ordinance and cause the same to be published as required by law; and this Ordinance shall take full force and effect 30 days after publication.
