

APPLICATION FOR SPECIAL CONDITIONAL USE PERMIT FOR
EXTRACTION OF SAND AND GRAVEL
WATERLOO TOWNSHIP

A Preapplication Conference is required prior to submission of an Application if a permit has not been previously granted for this parcel. This gives the applicant an opportunity to meet informally with Township Officials and Consultants and avoids unnecessary delays and costs associated with preparation, processing and review of the application. A Public Hearing before the Waterloo Township Planning Commission is required for Site Plan Review and consideration of this Application for Special Conditional Use. You should be present at that Hearing.

An Interim Payment is required with submission of this application. However, the actual fee will be determined by the Township Board at the time of Final Review of the Application for Conditional Use and will be due in full prior to issue of the Conditional Use Permit.
